

# VOTING AND THE MILITARY



## VOTING AS A UNIFORMED SERVICE MEMBER OR ELIGIBLE FAMILY

NORTH DAKOTA  
**SECRETARY OF STATE**



**If you are a U.S. citizen and live in North Dakota, you have the right to vote!**

Anyone who has lived in North Dakota for 30 days prior to an election can vote.

North Dakota does not require voter registration, but you do need to have a form of identification that can be used for voting. This means you should make sure you have proper identification with you before you go to the polls to vote.

### HOW DO I VOTE?

- You can vote by **absentee**, or by **mail**.
- You can vote at an **early** voting location.
- You can vote on **Election Day**.

### VOTER IDENTIFICATION

You need one of the following forms of ID to vote if using one of the options above:

- **North Dakota Driver's License**
- **North Dakota Non-Driver ID**
- **Tribal ID or Tribal Letter**
- **Long Term Care Certificate**

Military ID and passports can only be used when applying for a **Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) ballot**.

### UOCAVA BALLOT

As a **uniformed service member** or **eligible family member**, you have the right to vote using a **UOCAVA ballot** if you are **active duty and stationed away from home**. You should request a UOCAVA ballot within your **state of legal residence** which can typically be found on your Leave & Earnings Statement (LES). If possible, request your ballot at least **3 months ahead of a scheduled election** in your state of legal residence. You can use your **military ID or passport** when applying for a UOCAVA ballot.

Request your UOCAVA ballot through the Office of the Secretary of State if **North Dakota** is your state of legal residence **and you are stationed away from home**.



## UOCAVA BALLOT PROCESS IN NORTH DAKOTA

When **applying for a UOCAVA ballot** through the North Dakota Office of the Secretary of State or FVAP.gov, you have the option to **choose to receive your ballot electronically or in the mail**.

- Ballots will be sent electronically or by mail **46 days before the scheduled election** if the application is received by that deadline.
- Remaining applications will be fulfilled **within 2 business days** of receiving the UOCAVA ballot request.

### ELECTRONIC DELIVERY

1. If you choose to receive an electronic ballot, you will receive a secure link from your county auditor to complete your UOCAVA ballot.
2. You will mark your electronic ballot and return it to your county auditor.
3. The county auditor prints the completed ballot and stores it securely until the ballot can be processed and tabulated.

### MAIL DELIVERY

1. If you choose to receive your ballot by mail, a ballot will be mailed to the address specified on your UOCAVA request.
2. You should mark the ballot and seal it in the pre-paid postage envelope provided and mail back to the county.
3. The county auditor receives your ballot and stores it securely until the ballot can be processed and tabulated.

**UOCAVA ballots must be mailed or submitted electronically by the close of polls on Election Day.**
